Week of August 19

Trustees -

This was a week of drilling down on a number of our key initiatives: our One University accreditation work, fundraising coordination related to the University of Maine Graduate and Professional Center and Maine Center Ventures, and further investment in the University of Maine School of Law's future.

But first, I wanted you to be aware of a new communication coming from my office each week as we head in to the fall semester and a new academic year.

In the past, Rosa Redonnett, our Chief Student Affairs Officer, has released an internal weekly report showing "point in time" enrollment data compared to budget and a number of other data points. It's the data that populates the System enrollment report to the Board in November after our fall census, and we track it carefully, weekly, from late summer through that November report. Rosa does yeoman's work with our System "IR" team, including notably Robert Zuercher on this data, to produce and distribute the report each week.

As stewards of public support and our students' tuition dollars, we have no more basic fiduciary obligation than to manage our enrollments to budget and monitor the various data available to us to make accurate future projections and plans for spending and investment -- or course corrections if necessary. With Rosa and the IR team still behind this good work, the weekly report is now distributed from my office to signify the priority attention we are giving this issue.

You can see attached the report and cover email my office released on this last week.

As I reported to you last week, Trustees Erwin and Eames and I, along with Vice Chancellor Ryan Low and Chief of Staff and General Counsel Jim Thelen, are meeting weekly by phone to firm up our recommendations from the Law School Advisory Committee's July report. In addition to the investments we'll be making, we finalized a plan this week with USM President Glenn Cummings to transition the law school's budget and governance to the System level by FY2022 (with interim plans until then), with the Dean reporting to me as Chancellor. The law school will remain a critical component of the University of Maine Graduate and Professional Center, and in Portland it will continue to share certain administrative, facility, and student supports with USM where it is financially efficient and in our students' best interests to do so. There are details to work out yet, the most important of which we'll be reporting on more fully in September when we seek your approval. I wanted you to know already that we are making this important progress for the law school, which is an important asset to both the System and State.

... The University of Maine and University of Southern Maine will be critical partners with Maine Center Ventures to grow the Maine Center's interdisciplinary graduate programming and demonstrate the value of new facilities to house them, but they must also support and fund-raise for other priorities, and I am committed to helping them find that right balance. To that end, I met Thursday with Terry Sutton, the Maine Center deans, and the architects who are developing plans for facility needs to challenge them to conceive of space that is right-sized to the realities of 21st century education modalities, efficiencies, and student expectations -- all because I fully understand there must be fundraising capacity for our other critical needs as well.

Finally, as has been the case for several weeks running, my team gave considerable attention to our One University accreditation planning. I described last week for you our plan to finalize a statement of Guiding Principles that will frame the report and recommendation I'll bring to you in September. I've asked my Chief of Staff and our General Counsel Jim Thelen to review the Guiding Principles in draft form with Barbara Brittingham at NECHE to ensure that our starting point for this effort is on the right track. We will hear from Barbara early this week, I expect, and will then start the work to draft my recommendations for you. We expect to finalize our report to you by the end of this coming week, and post it for the Board's public agenda sometime later in the week following Labor Day. To my pledge to the Presidents for full transparency in our efforts, we will at the same time send out a System-wide message calling attention to the report, as well as the historical records we've generated in our correspondence with NECHE on One University efforts and related accreditation matters over the last four years.

Important days are ahead for us. Meantime, I hope you are able to enjoy all Maine offers on a late summer weekend.

Fall 2019 Enrollment Watch as of 8/19/2019 – The University of Maine System

This Enrollment Watch report compares enrollment data as of 2 Weeks before the start of classes (8/19/2019 vs. 8/20/2018), the Fall 2019 budget, and to the Fall 2018 census. Date-based figures are a snapshot of enrollment at a certain point in time.

Notes:

1. Data reflects activity through the end of the day (August 19, 2019 and August 20, 2018).
2. The enrollment period reflects enrollment as of 2 Weeks before the start of classes (September 3, 2019 for Fall 2019 and September 4, 2018 for Fall 2018).
3. All figures include both degree and non-degree enrollment.
4. Fall 2019 Budget is the projected budget submitted by each campus at the start of the fiscal year.
5. Fall 2018 Census represents the Fall enrollment census, which are data as of October 15, 2018.
6. Out of state figures include NEBHE, NEBHE Canadian, other out-of-state, international, and non-resident online/web students.
7. The formula for calculating Fall FTE (for all campuses except UMF) is as follows:

$$\text{Fall Undergraduate Credit Hours}/15 + \text{Fall Professional (Law) Credit Hours}/15 + \text{Fall Graduate Credit Hours}/9 = \text{Fall FTE}; \text{UMF: } \text{Fall Undergraduate Credit Hours}/16 + \text{Fall Graduate Credit Hours}/9 = \text{Fall FTE}.$$
8. Credit hour and FTE figures may not appear to sum correctly due to rounding.
