# RFP PROCESS OR DOCUMENT QUESTIONS

1. In regard to Table 2: Would you prefer separate excel files for each institution, or one continuous excel file for all of the institutions, clearly separated by institution?

# **ANSWER:**

Please use one excel file. As a reminder this Title IX Athletic Audit is for the University of Maine, Orono campus (refer to RFP Section 1.1.3). The other campuses are noted only to describe the University of Maine System and to allow for the other campuses the option to utilize any resulting agreement. Please structure your response for the University of Maine campus at this time.

2. On page 14 of the Submission Form Package, Appendix F, Question 8: We would appreciate clarification of the language ". . . business requirements identified in this document within higher education." We are interpreting this to mean the costs of achieving compliance with Title IX. Thank you for any clarification you can provide.

## **ANSWER:**

That is correct.

3. Assuming that the athletic audits are for the intercollegiate athletics programs, it appears that seven institutions (U Maine, UMM, UMA, UMF, UMFK, UMPI, and USM) have intercollegiate programs; the Maine School of Law and the Graduate and Professional Center do not. Additionally, it appears that the Maine Maritime Academy, Central Maine Community College, Southern Maine Community College, and York County Community College have intercollegiate athletics programs as well; Eastern Maine Community College, Kennebec Valley Community College, and Northern Maine Community College do not. Washington County Community College appears to offer one intercollegiate team. Thank you for any confirmation you can provide.

composition to the University of Maine System. Please provide a reference contact for the institution for which the plan was designed." The previous Title IX Athletic Audits that our team has done were completed through the affiliate law firm of INCompliance, Bricker Graydon LLP. With that, these audits are subject to attorney-client privilege and we are unable to share names of these clients. Will we be docked or disqualified for not sharing names/references associated with this section?
